Scala Sans is suggested for use on all materials related to the Van Valer brand identity.

SLOGAN USAGE

The official slogan for Van Valer Law Firm is Built On Relationships...Sustained on Success Note: There is no punctuation included, each first letter is capitalized.

OUR LOGO COLORS

The logo, in its preferred form, is a two-color logo. The Van Valer logo colors are PANTONE MATCHING SYSTEM (PMS) 5753 Green and black.

The logo may also appear as a one-color logo in all black with 70% black as noted in the logo below. No other colors for the logo are allowed.
